The Club doesn't just fundraise: we also like to roll up our sleeves and get our hands dirty. For the Bikes for Tikes project, members assembled over 100 bicycles as holiday presents for local children in partnership with the YMCA and other organizations. We also worked with other Rotary Clubs and the Virginia Living Museum to help build the new Dinosaur Trail. Another recent grant project was to revitalize a local day care to encourage childhood education. Parents have told us that the children wake up looking forward to learn. While I may never meet these children, working for them has strengthened my love for the Hampton Roads community and my commitment to helping others, as a Rotarian and as an attorney.
